Announcing 2011 IEA Liberty Mutual Medal Winner

The IEA review committee has selected the winner of the 2011 IEA/Liberty Mutual Medal in Occupational Safety and Ergonomics and the appropriate boards have endorsed the selection of a paper by Marie Ward, Nick McDonald, and Rabea Morrison, of the Aerospace Psychology Research Group (APRG), School of Psychology, Trinity College (Dublin) and Des Gaynor, M.A., and Tony Nugent of Trinity aeroTec (Dublin). The paper, "A Performance Improvement Case Study in Aircraft Maintenance and its Implications for Hazard Identification," was published in and nominated by the journal *Ergonomics*. We extend our heartiest congratulations to the authors on receiving the most prestigious recognition in our field for this research. Important IEA Administrative Matters

We will have a full agenda when we meet for our Council meeting in Recife, Brazil on February 11 and 12. You are invited to a brief Council reception on Friday evening, February 10 at the Golden Tulip Hotel. A New Council Member Orientation will precede this reception. Details will be forthcoming. Save the dates!

Federated Societies have already received a draft of proposed changes of the IEA Rules and Operating Procedures, which we will vote on at that meeting. We are awaiting your feedback before releasing the voting item. We will also be voting for the new officers, venue for the 2018 Triennial Congress (with four good proposals), and the venue for the 2013 Council meeting.

Call for Nomination of Officers

There will be an election for the next IEA President, Vice President Secretary General, and Vice President Treasurer. Nominations will be received from the Federated Societies on the attached Nomination Form and Statement from the Candidate Form. These forms must be received by December 11, 2011. Council will be informed of the nominations for the IEA Executive Office by December 30.

We urge you to nominate willing and able leaders for these critical roles in the IEA. We look forward to receiving your input!

Proxy Votes

We will be voting on several matters that require a quorum and it is important that we get the required representation in voting. If no one from your society will be attending the Council meeting, we urge you to vote by proxy (please fill out the attached Proxy Statement and send to Eric Wang by January 15, 2012). If you know that another society will not attend, please contact them to encourage them to assign their proxy votes.

IDC Support to Attend IEA2012

A select group of federated societies received notices that the IEA will support one member nominated by the society to receive a stipend of \$500USD. Presidents of these federated societies must submit their nomination to Eric Wang. The stipend will be paid to the named recipient on the second day of the Congress.

Paypal Option for Paying Dues

As a reminder, it may be advantageous for some members to make their dues payment using the Paypal option that Klaus Zink and his team have established. It could be less expensive and more convenient for your society to use this option depending on the amount of the payment.
